## Vendor Space Rental Agreement and Application Form Rules and Information for Vendor

<b>Friday August 14, 2026</b>	<b>4pm-11pm</b>
<b>Saturday August 15, 2026</b>	<b>11am-11pm</b>
<b>Sunday August 16, 2026</b>	<b>11am-8pm</b>

Each vendor will be granted an allotted **10 x 10' space**. Additional space may be available at an additional cost, and subject to availability. Each vendor who submits the enclosed form shall expressly agree to the following General Information, and Terms and Conditions:

### General Information:

- 1) Hamilton Greek Fest is the **ONLY** Licensed Food Vendor during the event. No other vendor who provides ready-made food or drink made for consumption at the event grounds is permitted.
- 2) The fee to rent a vendor space is **\$300**, for "Early Bird" registrants. To qualify for the "Early Bird" special pricing, a completed copy of this form and full payment must be submitted to Hamilton Greek Fest by end of day **July 15, 2026**. The regular fee to rent a vendor space increases to **\$350** between July 16, 2026 and July 31, 2026 (the last day to register).
- 3) **You are responsible to bring your own tent (10x10'), tables, chairs, and display stands, electrical cords for connections** No generators permitted. The space includes electrical power (maximum 15amp outlet).
- 4) Vendor parking is not available on the premises. Vehicles or trailers are not allowed in the area as part of your booth display.
- 5) Set up your booth by **2pm on Friday August 14, 2026**. Vendor must be prepared to have its exhibit intact and ready from **4:00pm on Friday August 14th, 2026 until Sunday August 16, 2026 8:00pm**.
- 6) Under no circumstance, should you close your booth down during show hours without consulting the Festival Coordinator. At the daily close of the Festival, vehicles are not allowed into the Festival area until all visitors have the opportunity to leave safely. This will likely be at 11:30pm Friday and Saturday, and 8:30pm Sunday.
- 7) **Vendor must** Confirm participation, which includes submitting this completed form and relevant payment no later than **July 31, 2026**.
- 8) Vendor must provide **Certificate of Insurance (with minimum coverage of \$5,000,000)**

10) Please advise the Vendor Coordinator of your power requirements in advance.

### **Terms and Conditions:**

1. Booths will be open to the public for the date & hours which the Festival has been advertised. Under no circumstance will the booth close during the Festival hours without consulting the Festival Coordinator or Chairman.
2. As a vendor, I will be responsible for my own property and liability insurance. Hamilton Greek Fest and Panagia Greek Canadian Community of Hamilton and District are not responsible for any equipment or personal property left on site by a Vendor. While there will be general security patrolling the Event site, vendors are responsible for the security of all of their personal property.
3. Each vendor is expected and agrees to maintain the allotted space in a professional, clean and safe manner and to remove all related garbage and debris, on a regular basis to the garbage disposal facilities provided. Unless otherwise agreed to in writing, booth displays will be confined to the allocated contracted space. Final assignments of booth spaces will be at the discretion of the Event Organizers and we reserve the right to reassign space assigned to a vendor.
4. Sharing or subletting of space is absolutely prohibited. This agreement cannot be altered, changed, modified or otherwise transferred by either party without consent of both parties and shall not be considered a joint venture or partnership between vendors and the sponsoring organization.
5. The Event Organizers reserve the right to refuse the selling or giving away of any articles, services, products or printed items that are deemed objectionable and/or offensive by the Chair and/or Coordinator of Hamilton Greek Fest. Vendors are to have the above-mentioned items removed from booth upon notice.
6. The applicant undertakes to observe all the rules and regulations, which are imposed by the Event Organizers and its agents, and the City of Hamilton their representatives generally or specifically in respect of the space which is being used.
7. In signing this application form, a Vendor hereby agrees to, and indemnify and hold harmless and defend, the Event volunteers or employees from and against any and all liability, responsibility, loss, damage, cost or expenses of any kind including but not limited to costs, interest, or attorney's fees which Hamilton Greek Fest and/or Greek-Canadian Community of Hamilton and District may incur, suffer, be put to pay or be required to pay, incident to or arising directly/indirectly from any intentional or negligent act or omission by the Vendor.

I release Hamilton Greek Fest and/or Greek-Canadian Community of Hamilton and District from any and all claims thereof. I shall indemnify and save harmless Hamilton Greek Fest and/or Greek-Canadian Community of Hamilton and District, its members, volunteers and employees from any claim for damage arising out of or in consequence of my use of the exhibition space granted by this contract.
